

FIREARM AND AMMUNITION TRANSPORTATION

Alison's Relocations understands that many of our customers plan to transport firearms and/or ammunition with their household goods shipment. We utilize a few methods of transportation, each with its own distinct rules for firearms and ammunition transportation. Therefore, we ask that you review the following information to ensure that your move is successful and without incident. Our staff can advise you what means of transportation your shipment will be traveling; please do not hesitate to contact us if you have any questions.

FIREARM & AMMO TRANSPORTATION- FOR OVER THE ROAD

Over The Road (Alcan) transportation involves and is subject to Canadian Customs Laws, therefore we ask that you review this information to assure your firearms transportation moves without incident.

Ammunition may be transported over the road with a per trailer limit of up to 4999 rounds.

Firearms: All firearms parts and ammunition must be kept separate from your household goods shipment and NOT PACKED or concealed in any way. Please ensure all firearms are located in a designated location so the moving crew can notate pertinent information on your inventories and firearm manifest; the mover will record each serial number, make and model. This includes bb guns because during the x-ray process the toys can look like undeclared weapons.

Gun safes and gun cases (soft & hard) may not be locked at any time during transit.

Failure to declare firearms will result in severe penalties and probable confiscation at the Canadian or Alaskan borders.

Alison's movers will stage your firearms on the tail of your trailer and provide the driver with your firearm manifest in preparation for customs clearance.

FIREARM & AMMO TRANSPORTATION- FOR OCEAN

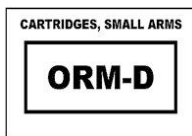
Ammunition may not, *under any circumstance*, be transported on the ocean via steamship (self-propelled ocean vessel) Matson, Inc.

Ammunition may be transported on the ocean via barge AML (Alaska Marine Lines).

****All ammunitions must be loaded into the last and final tier of the load. There are no limits for quantity.**

Ammunition may be transported on the ocean via carrier YRC.

****Each case/carton of ammunition may not weigh more than 66 lbs. There are no limits for quantity. Each case/carton must be labeled "Cartridges, Small Arms – ORM-D" and must be loaded into the last and final tier of the load.**



Example:

Firearms: Please ensure all firearms are located in a designated location so the moving crew can notate pertinent information on your inventories; the mover will record each serial number, make and model.

With all ocean carriers the Firearms may be packed and placed within any part of the shipping container/trailer.

Storage: As a military approved carrier, Alison's Relocations, Inc. may not store ammunition per D.O.D (Department of Defense) regulations.

Carriers tariffs and customs regulations are stringent, well defined and must be followed to the best of our ability. **We feel it is important to note that Alison's Relocations has never been assessed a violation or been involved in a confiscation of ammunition or firearms.**
